## SCHOOL FEES 2026

Following the AGM Resolution meeting held on, Wednesday, 16 October 2025, the school fees for 2026 was set as follows:

*Although school fees are payable annually in advance, there is a concession, that the school fees may be paid monthly as follows:*

- 1.1. Gr 8: R 31 700 per learner** (Includes compulsory Gr 8 Camp and Welcoming Program)
  - R5 700 1st payment, payable before 30 November 2025
  - R2 600 x 10 installments payable monthly before the 1<sup>st</sup> day of the month from 1 February 2026
- 1.2. Gr 9 to 11: R 29 500 per learner**
  - R4 500 1st payment, payable before 30 November 2025
  - R2 500 x 10 installments payable monthly before the 1st day of the month from 1 February 2026
- 1.3. Gr 12: R 29 500 per learner**
  - R4 300 1st payment, payable before 30 November 2025
  - R4 200 x 6 installments payable monthly before the 1st day of the month from 1 February 2026

**NB :** In addition to school fees the Matric Dance fees of R1 500.00 will also be payable by 1 April 2026 (not included in the R29 500 school fees). Further detail related to the Matric Dance 2026 will be shared in due course
- 1.4. Discount for early settlement of School fee Accounts:**
  - Discount of R3 000 if all fees are fully settled before 1 April 2026
  - Discount of R2 000 if all fees are fully settled before 1 July 2026
  - Discount of R1 000 if all fees are fully settled before 1 October 2026

Payments that cannot be identified, will be allocated to our suspense account. Please note that your financial account reference number is on your account statement.

Provision is made for parents in need with regards to School Fees exemption. Eligible parents may collect the required documentation from the Admissions office. Parents must submit the completed application form to the Finance Office. Application for School Fee Exemption must be completed annually.

If one monthly school fee payment is in arrears, the full outstanding amount will be payable immediately. In this case, the Governing Body reserves the right to take legal action immediately (including debt handover and to blacklisting). Funds paid by parents will first be allocated to school fees and then to any other account.

The school appreciates parents who faithfully fulfil their obligations.
